Interpreting the Bible	Berkeley Michaelson	Book	Scholarly resource published in 1963 that offers a deep dive into hermeneutics, or interpreting the Bible.

Centered-Set Church: Discipleship and Community without Judgmentalism	Mark Baker	Book	A theologian and educator, Baker aims to present an alternative approach for nurturing Christian community that avoids <i>both</i> the tendency to draw lines around what it means to be "a good Christian" as well as the tendency to erase all the lines in favor of a vague and inoffensive faith.

While NSCBC is <i>not</i> considering infant baptism as a practice, this book provides insight into the views of those who do not wish to be re-baptized.

Introduction to the Contemporary Gender Debate	Ron Pierce	Video Lecture	This 50-minute lecture is an introductory class at Biola University that shares the key ideas, ministry leaders, and history of egalitarianism and complementarianism. Men, Women, and Biblical Equality	Christians for Biblical Equality	Position paper	This position paper published in 1989 articulates a biblical rationale for gender equality in all areas of life, including ministry and leadership. It is historically significant as a founding document for the egalitarian or mutualist movement within evangelical Christianity. It was signed by a few people who belonged to NSCBC. Christians for Biblical Equality continues to publish resources advocating for mutuality between men and women in ministry. See CBE's searchable resource list.
Scriptural Support for Women in Ministry and A Wesleyan View	Wesleyan Church	Article + Statement of Belief	These document the biblical foundation for the Wesleyan stance on women in ministry, examining the arc of the Bible from Genesis to Revelation. This may interest those curious about how a denomination with many similarities (and some important differences!) approaches the matter.
Statement and four-part video lecture series	Bridgetown Church (Oregon)	Position paper and video	Bridgetown Church conducted a process similar to ours, resulting in a statement and teaching series explaining their conclusions.
Announcement to church and paper on process, study of Scripture and conclusions	Bent Tree Church (Texas)	Position paper and video	Bent Tree Bible Fellowship conducted a process similar to ours, which resulted in an announcement to the church and a paper to capture where they landed.
